A Resolution of the School Board of Volusia County, Florida,
Proclaiming the week of January 13-17, 2014 as
"Celebrate Literacy Week" for the School District of Volusia County

KNOW ALL CITIZENS BY THESE PRESENTS, that the Volusia County School Board, a political subdivision of the State of Florida, hereby recognizes the week of January 13-17 2014, as "Celebrate Literacy Week" in order to focus attention on the importance of reading.

WHEREAS, helping every student in the K-12 system to read at or above grade level and making literacy the priority of every citizen in Volusia County; and

WHEREAS, changing the culture of our schools from Pre-Kindergarten to postsecondary by raising the ceiling and raising the floor to better enable students for success in the 21st century; and

WHEREAS, raising awareness of the literacy programs and projects offered and to increase involvement in these programs and projects; and

WHEREAS, aiming to promote the enjoyment of reading for all ages, children to adults; and

WHEREAS, parents, families, neighbors, and mentors play a crucial role in helping children learn to read; and

WHEREAS, Just Read, Florida!, is a comprehensive, coordinated reading initiative aimed at helping 2.6 million students become successful, independent readers and has thus been recognized as a national model; and

WHEREAS, the Florida Department of Education's mission is to increase the proficiency of all students within one seamless, efficient system, by providing them with the opportunity to expand their knowledge and skills through learning opportunities and research valued by students, parents, and communities; and

WHEREAS, Rick Scott, Governor of the State of Florida, does hereby extend greetings and best wishes to all observing January 13 through 17, 2014, as Celebrate Literacy Week!


