RESOLUTION NO. 2015-09

A Resolution of the School Board of Volusia County, Florida, expressing support for the City of Holly Hill's grant application for a feasibility study for sidewalk construction on local roads.

WHEREAS, the Transportation Planning Organization facilitates the planning, development and implementation of projects that will improve safety and reduce traffic and encourages children to walk and bicycle to school; and

WHEREAS, the Florida Department of Transportation has grant programs to allocate federal funds to eligible applicants; and

WHEREAS, Volusia County School District staff has participated in the TPO's Bicycle Pedestrian Safety Studies around area elementary and middle schools; and


WHEREAS, the School Board of Volusia County desires to support the multiagency effort to provide safe and alternative modes of transportation;

NOW, THEREFORE, BE IT RESOLVED BY THE SCHOOL BOARD OF VOLUSIA COUNTY, FLORIDA, IN OFFICIAL SESSION, DULY ASSEMBLED IN DeLAND, FLORIDA, THIS 17TH DAY OF MARCH 2015, AS FOLLOWS:

That the School Board of Volusia County supports the City of Holly Hill's grant application for a feasibility study to construct sidewalks on Flomich Street between Nova Road and Center Avenue, a feasibility study to construct sidewalks on the east side of Center Avenue between Flomich Street and LPGA Boulevard; and a feasibility study to construct sidewalks continuing south on Center Avenue from LPGA Boulevard to the southern city limit.

BE IT FURTHER RESOLVED that this resolution be spread upon the minutes of the School Board of Volusia County, Florida, submitted to the Transportation Planning Organization, and be used to supplement the City of Holly Hill's grant applications.




