

A Resolution of the School Board of Volusia County, Florida,  
Proclaiming the week of October 1- 9, 2015, as  
"Disability History and Awareness Week" for the School District of Volusia County

KNOW ALL CITIZENS BY THESE PRESENTS, that the Volusia County School Board, a political subdivision of the State of Florida, hereby recognizes the week of October 1 - 9, 2015, as "Disability History and Awareness Week," and encourages student and teacher participation in activities which increase their knowledge, understanding, and awareness of individuals with disabilities, the history of disability, and the disability rights movement.

**WHEREAS**, Florida's education system is based upon the principle that all individuals shall have the opportunity to gain the knowledge and skills necessary to achieve their full potential and contribute to the general welfare of the community; and

**WHEREAS**, educational programs for students with disabilities incorporate this fundamental principle; and

**WHEREAS**, students with disabilities receive a variety of specialized services and instruction that enable them to participate in, and benefit from, educational activities; and

**WHEREAS**, access to assistive technology and communication devices, such as Braille, large print materials, sign language, and other accommodations to the general curriculum, allow students with disabilities to participate in classroom activities, benefit from instruction, and demonstrate their capabilities; and

**WHEREAS**, students with disabilities are provided with transition services to prepare them to attain their desired post school outcomes including post secondary education, employment, and adult living; and

**WHEREAS**, the State of Florida has demonstrated its commitment to school improvement and accountability for all students which will increase positive outcomes for students with disabilities ages birth through 21; and

**WHEREAS**, Florida teachers, paraprofessionals, and other educators work daily to assist these students and their parents to achieve their goals and progress on the path to excellence; and

**WHEREAS**, their contributions are worthy of recognition and appreciation.



Section 1. 




