**RESOLUTION NO. 2016-22**

**A RESOLUTION OF THE SCHOOL BOARD OF VOLUSIA COUNTY, FLORIDA, ADOPTING THE FINAL BUDGET FOR THE FISCAL YEAR 2016-2017 FOR THE GENERAL FUND, CAPITAL PROJECTS FUND, DEBT SERVICE FUND, SPECIAL REVENUE-FOOD SERVICE FUND, SPECIAL REVENUE-OTHER FUND, AND INTERNAL SERVICE FUND OF THE SCHOOL BOARD OF VOLUSIA COUNTY, FLORIDA; REPEALING ALL RESOLUTIONS IN CONFLICT THEREWITH; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.**

*WHEREAS, the School Board of Volusia County, Florida, is authorized under the Constitution and Laws of Florida to levy a tax upon non-exempt real property, lying and situated in Volusia County, Florida, for public school purposes, and adoption of a Final budget, and*

*WHEREAS, the required public notice has been given, and the public has been given an opportunity to be heard and to ask questions regarding the Final budget for the 2016-2017 fiscal year, and*

*WHEREAS, all matters required by law pursuant to the adoption of the Final budget for 2016-2017 have been satisfied,*

**NOW, THEREFORE, BE IT RESOLVED THAT THE SCHOOL BOARD OF VOLUSIA COUNTY, FLORIDA, HEREBY ADOPTS THE FINAL BUDGET, WHICH CONTAINS THE FOLLOWING FUNDS AND APPROPRIATIONS FOR THE 2016-2017 FISCAL YEAR:**
