Note 2: Sanitizer solution 200ppm., Sanitizer 3c/s 200 ppm.

Note 3: Facility was exterminated for roaches, dead roaches were observed and cleaned up in area. No live activity observed in areas. Monitoring stations were placed in areas, no dead roaches observed in stations. Facility to be checked again within a week.
