Observed blackish brown viscous liquid pooling on floor of walk in refrigeration unit, toward back of unit. Clean area.
CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.
