The temperature of the chicken in the salads stored in the reach-in cooler at the serving line measured at 50 degrees F. All ingredients of cold salads must be prechilled to below 41 degrees.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held cold, and not subject to an approved HACCP plan, must be maintained at 41°F.
